I should also have taken the opportunity to remind you that the OMA is conducting a PPE survey, and it is important to complete the survey to ensure our needs are also being tracked through the OMA.

With respect to the use of N95 masks, I understand the WECHU has already received a number of requests for these types of masks. Kristy McBeth has pointed out that: "based on the current IPAC recommendations, a surgical mask would be recommended for most provider interactions including assessment and swabbing, with the exception of any aerosol-generating medical procedures. Providing N95 masks also requires individuals to have been tested for properly sized and typed masks, so it also wouldn't be appropriate to drop off ill-fitting masks".

I am re-attaching the document from yesterday regarding PPE for your information.

Page 3 outlines the use of N95 respirators for care of individuals with suspected/confirmed COVID-19, and is broken down by practice setting.

Page 6 provides guidelines for use of procedural/surgical masks by health care providers. Page 9 discusses strategies for conserving PPE, which is important given the current availability of supplies.

## 3) Maternal-Newborn Care
